This Amendment No. 1 is being filed jointly by the Reporting Persons and amends the Schedule 13G initially filed by the Reporting Persons with the Securities and Exchange Commission (the “SEC”) on February 11, 2020 (the “Schedule 13G”).

Except as set forth below, all Items of the Schedule 13G remain unchanged. All capitalized terms not otherwise defined herein shall have the meanings ascribed to such terms in the Schedule 13G.

Item 4. Ownership.

(a) and (b):

As of the close of business on December 31, 2020, each of the Reporting Persons may have been deemed to have beneficial ownership of 265,927 Ordinary Shares, which consisted of (i) 5,000 Ordinary Shares held by Intracoastal, (ii) 240,000 Ordinary Shares issuable upon exercise of a warrant held by Intracoastal (“**Intracoastal Warrant 1**”) and (iii) 20,927 Ordinary Shares issuable upon exercise of a second warrant held by Intracoastal (“**Intracoastal Warrant 2**”), and all such Ordinary Shares represented beneficial ownership of approximately 6.3% of the Ordinary Shares, based on (1) 3,948,226 Ordinary Shares outstanding as of November 5, 2020 as reported by the Issuer, plus (2) 240,000 Ordinary Shares issuable upon exercise of Intracoastal Warrant 1 and (3) 20,927 Ordinary Shares issuable upon exercise of Intracoastal Warrant 2.

(c) Number of shares as to which each Reporting Person has:

(i) Sole power to vote or to direct the vote: 0.

(ii) Shared power to vote or to direct the vote: 265,927.

(iii) Sole power to dispose or to direct the disposition of 0.

(iv) Shared power to dispose or to direct the disposition of 265,927.
