Asher, an individual who is a citizen of the United States of America (“**Mr. Asher**”) and (iii) Intracoastal Capital LLC, a Delaware limited liability company (“**Intracoastal**” and together with Mr. Kopin and Mr. Asher, collectively the “**Reporting Persons**”).

(i) Immediately following the consummation of the underwritten public offering by the Issuer on February 4, 2020 (the “**Offering**”) (as disclosed in the Form 8-K filed by the Issuer with the Securities and Exchange Commission on February 3, 2020), each of the Reporting Persons may have been deemed to have beneficial ownership of 5,216,817 Ordinary Shares, which consisted of (i) 5,000,000 Ordinary Shares held by Intracoastal and (ii) 216,817 Ordinary Shares issuable upon an exercise of a warrant held by Intracoastal (the “**Intracoastal Warrant**”), and all such Ordinary Shares in the aggregate represent beneficial ownership of approximately 9.99% of the Ordinary Shares, based on (1) 52,003,580 Ordinary Shares outstanding immediately following the Offering as reported to the Reporting Persons by the Issuer, plus (2) 216,817 Ordinary Shares issuable upon an exercise of the Intracoastal Warrant. The foregoing excludes 4,783,183 Ordinary Shares issuable upon exercise of the Intracoastal Warrant because the Intracoastal Warrant contains a blocker provision under which the holder thereof does not have the right to exercise the Intracoastal Warrant to the extent (but only to the extent) that such exercise would result in beneficial ownership by the holder thereof, together with the holder’s affiliates, and any other persons acting as a group together with the holder or any of the holder’s affiliates, of more than 9.99% of the Ordinary Shares. Without such blocker provision, each of the Reporting Persons may have been deemed to have beneficial ownership of 10,000,000 Ordinary Shares.

(ii) As of the close of business on February 10, 2020, each of the Reporting Persons may have been deemed to have beneficial ownership of 5,287,761 Ordinary Shares, which consisted of (i) 4,360,800 Ordinary Shares held by Intracoastal and (ii) 926,961 Ordinary Shares issuable upon exercise of the Intracoastal Warrant, and all such Ordinary Shares represented beneficial ownership of approximately 9.99% of the Ordinary Shares, based on (1) 52,003,580 Ordinary Shares outstanding immediately following the Offering as reported to the Reporting Persons by the Issuer, plus (2) 926,961 Ordinary Shares issuable upon exercise of the Intracoastal Warrant. The foregoing excludes 4,073,039 Ordinary Shares issuable upon exercise of the Intracoastal Warrant because the Intracoastal Warrant contains a blocker provision under which the holder thereof does not have the right to exercise the Intracoastal Warrant to the extent (but only to the extent) that such exercise would result in beneficial ownership by the holder thereof, together with the holder's affiliates, and any other persons acting as a group together with the holder or any of the holder's affiliates, of more than 9.99% of the Ordinary Shares. Without such blocker provision, each of the Reporting Persons may have been deemed to have beneficial ownership of 9,360,800 Ordinary Shares.
